WATERWISE:

- Another good turnout. Nik Sams and his wife are a great support and are happy to continue with this.

GENERAL BUSINESS

- Garden shed to back of club house has now been completed and has relieved storage issues inside
- BBQ for Sunday Sounds went well with committee running it. Will look to keep it going.
- Mike Dance requested details of current bad debtors in yard. We need to address these issues once again and hopefully get some final resolution. Michelle suggested Roger is consulted in this process as he is not present tonight and has been working with this for a while now and can assist with this.
- Mike Dance has asked for input on the haul out incident that happened last week. We need to
 address any weak points in our current system and documents so as to improve our
 management and help prevent these situations happening again
- Suggestions from floor for consideration by yard management sub-committee:
 - Boats >10 tonne as specified on agreement require a weight certificate, and especially boats we don't know or boats whose weight details we are suspicious of i.e. new members
 - Minimum of 3 months as a new membership before the boat can be booked for haul
 out. If there is an available space before that timeframe is completed we may consider
 allowing a booking but they pay a higher non-member rate
 - All cradles and gear to be checked for and ensue they are up to date for weights and certification etc
 - Michelle asked to insert the cradle weight we have into current haul out agreement and update on web site. Also to look into creating an online booking form for haul outs and to better the administration process to try help ensure a tighter haul out process
 - This incident has prompted a review of our terms and conditions and haul out application process, and we will get this in place as soon as possible
