YARD REPORT:

- One container has been removed which has created more space.
- The yard has been cleaned and all boats are in order and under a settled work environment and looking tidy and safe for users.
- Bad debtors have been contacted some of which have made pro-active responses from members.
- Repairs and greasing of wheel bearings are ongoing as a regular maintenance plan
- The Venita-Jean boat that has been successfully purchased, however there is a delay in moving this, due to repairs needed to remove the boat. However, the new owner has been billed and things are progressing well.
- Both trolleys are up and running, with general maintenance required.
- It has been proposed that a certificate of vessel weight to be required as part of the hall out agreement.
- A solution and cost has been provided for the repair of the dry shelter, which is moving forward.

CLUB REPORT:

- The Club has been through a Food Safety rating, which Michelle has put a lot of work on, consequently the club has received an 'A' rating.
- Everything is running reasonably smoothly

HEALTH AND SAFETY:

- The purchase of the Scaffolding for \$1,800 has been moved by Roger, this has then been passed by Steve Sharp.
- Concerns around scaffolding that may be purchased by the club and the safety of users has been raised. For members to use this in the yard, it does pose the question of Health and Safety for users, and a plan will need to be put in place to ensure members are using the equipment are safe.

BUILDINGS & INFRASTRUCTURE:

- One of the pontoons has been found floating down the river. This has been rescued and secured. Further plans are being made to ensure the pontoons are safely secured.



EVENTS COMMITTEE:

- The Kokedama class was a hit and had a great response for a wide audience in the community, this has resulted in Little Worlds booking in another class on the 24th of July.
- Karaoke has been booked in for the 10th of July.
- Bounty of the Sea has been pencilled in and the processes has been started for the 6th/7th November. This does involve a sub committee which will present the status to the new committee after the AGM.
