The Boating Club at Stillwater occupies Buster Elliott Memorial Reserve on Duck Creek Road, and is on the Weiti River. Our amenities include ramp, members wharf, pontoon, grid, hard stand / haul out area, members dinghy lockers, work sheds, and club rooms with bar and kitchen.

The club was inaugurated in 1971. The ramp was opened in 1981, and improvements continued in the original spirit of volunteers and self-funding, until 2016. The Reserve as it appears today is on reclaimed land, a long slog for the original members of the club who were determined to create an all tide ramp and suitable haul out facilities. The reserve, wharf, original ramp and club rooms have all been built with volunteer labour from both the local community and club members.
